From the Editors Desk

In December, I was riding my bike along the Coyote Creek Trail next to Los Lagos golf course and saw a bobcat walk across the trail and head down into the creek. For the geographically impaired, this is three miles upstream of Naglee Park.

I never expected to see a bobcat in the valley and certainly not this close to downtown. But it points out what a jewel Coyote Creek is. The creek is a corridor for wildlife traveling through San Jose. While many of us have experienced racoons, oposoms and other more common urban wildlife, the creek brings us bobcats, wild turkeys, song birds and other critters that you wouldn't expect in the center of a major city.

Unfortunately it is still a little difficult to experience the creek and its wildlife. The Coyote Creek trail is incomplete, it extends from Morgan Hill to near Tully Road, then goes missing (except for a half mile stretch in Selma Olinder Park) until Montague Expressway. Plans are in the works to extend the trail from Kelly Park to Watson Park, but it is unclear how long that will take and it still leaves gaps in the trail. The best way for neighbors to experience the creek now is to join up on a creek clean-up that the Friends of Coyote Creek organize. Creek clean-ups put you on the water in canoes and small boats, where you can see water fowl, turtles, and critters that you can't see from the creek trail. At the same time, you can help clear the creek of trash.

You should be aware that the Santa Clara Valley Water District is beginning the Mid-Coyote Creek Project to provide flood protection, restore habitat, and improve water quality. The project area extends from 101 to 280 and will impact the existing wildlife corridor. The nature and extent of these impacts will depend on the final scope of the project. The Water District has held three public meetings on the project. Pres' Says

Another Spring has almost come to Naglee Park (although as I write this we are just ending several weeks of freezing weather, and our garden will need major repair in a few weeks when it warms up). But, hopefully, with some hard work and tender loving care our yard will eventually see another bud break, and sometime later an abundance of spring flowers.

Caring for the neighborhood and working with the City is much the same. There is always much to do, and it is a challenge to juggle many meetings on multiple issues. Sometimes things seem to change so slowly one can wonder if the effort is worth it and if these efforts will ever bear fruit. But at other times things look to be on the verge of a spectacular bloom.

For many years a dedicated group has been working to convince the City to recognize us as a resource and to integrate the input of our neighborhoods into the City's decision-making process. This year, we may see this fervent hope become a reality. I have had the opportunity to serve on a group that is in the process of refining its' original draft proposal for a San Jose Neighborhoods Commission. This idea grew out of the Strong Neighborhoods Initiative Project Advisory Committee. After working together for over five years, and knowing that the SNI PAC is set to "sunset" this June, we decided that the best legacy we could leave the City is to assure that there would be a permanent body to advise San Jose City Leadership on issues of significant community interest, and be a resource to them on neighborhood quality of life matters. This Neighborhoods Commission would represent all neighborhoods, not just those in the redevelopment project areas, and also be available to neighborhoods as a bridge and support in their dealings with the City.

Last October the past Council accepted this concept for study, and directed our group to keep working on this project. We have been meeting twice weekly

since that time (at 7 a.m. in the mornings on weekdays before work), and also have been doing outreach and getting input from neighborhood associations all over the City. We have learned so much about the concerns of other neighborhoods though this process and are integrating this into our draft proposal, which we will then take out for further review. If all goes as hoped and we stay on our timeline, we will see the birth of the San Jose Neighborhoods Commission in 2007. If this is of interest or you have ideas, send me an email and share your thoughts.

The other piece of good news was the recent Budget Priority Planning Session held by our new Mayor Chuck Reed. I have to admit, I have been to many of these types of meetings and usually it's an early Saturday morning starting with a weak cup of coffee and an agenda of being told that are limited dollars. This meeting seemed decidedly different, as it was held before the City has really gotten rolling in the budget planning process and we were told that the City wanted to hear neighborhood priorities before the department budgets were developed. In a well-run three hour meeting, neighborhood leaders from all areas of San Jose were asked to prioritize what was most important to us. Interestingly, whether a neighborhood was in the Redevelopment Project Area or not, we had many of the same priorities and concerns (ensuring adequate police protection, safeguarding neighborhoods from slumlords, providing quality recreational facilities to youth, and improving the financial condition of the City to ensure we can do all these things now and in the future). Washington Report

In the first two weeks of the 110th Congress, every part of the Democrats' 100 Hours Agenda passed with strong, bipartisan support. We created real ethics reform and voted to implement the recommendations of the 9/11 commission, raise the minimum wage, and advance stem cell research. We acted to bring down the cost of prescription drugs, enacted changes in the student loan program to make college more affordable, and voted to invest in renewable energy.

Because we need to make sure that all qualified students have the ability to go to college, our bill to cut the interest rate on subsidized student loans for undergraduates in half over the next five years is especially important.

Another important issue -- ending America's dependence on oil -- has been a priority of mine and is a concern expressed to me by many of my neighbors in Naglee Park. Our repeal of \$14 billion in subsidies to Big Oil companies, with a plan to invest those funds in clean, renewable energy resources and the development of new energy technologies, is a good first step toward achieving energy independence.

On another note, like many of you, I strongly disagree with the President's proposal to escalate troop engagement in Iraq. I voted against invading Iraq in 2002, and I do not intend to vote to give the President a blank check to continue his misguided Iraq policy.

A better solution would include utilizing diplomacy in the region as recommended by the bipartisan Iraq study group, having the Iraqi leadership and people take more responsibility for their security, and beginning a phased redeployment of our forces in the coming months. With a new Congress that will no longer give the President blanket approval, I am hopeful that we can force an end to the President's misguided war.

neighborhood organizations prioritized the following five City neighborhood funding priorities (in no particular order):

- Increase the number of jobs in the City.
- Improve proactive code enforcement
- Provide full funding for parks, pools, community centers and libraries, including maintenance and operations and development.
- Improve community policing in the neighborhoods.
- Improve general fund revenue.

Let's all be watching the development of the City budget this year, and add our voices to this process in an ongoing way, to assure that neighborhood priorities are addressed. Our new Councilperson Sam Liccardo recently attended our January Campus Community Association General Meeting, and his commitment is to ensure that our District Three City Council Office is responsive to our community. Let's all support Naglee Park and downtown in being the best it can be.

Naglee Park Prepared Are you Prepared?

The major obstacle to disaster preparedness is our hope that such a serious event will not befall our neighborhood. As one of the Naglee Park Prepared coordinators (Rich Eilbert is the other), I certainly do not want to stir up anxiety. In fact, our neighborhood would most likely not suffer serious damage if a major quake struck the area.

Ever since I taught health classes in high school, however, I have learned that being prepared for emergencies makes every emergency more manageable. So, if you read over your green preparedness manual and discuss with your family, roommate, or neighbors how to prepare best, you will find, I believe, that you will be less anxious and more ready for any emergency.

On April 7 we will have our neighborhood disaster simulated drill. At 10 a.m. pretend that there is a violent earthquake. Please put a green paper from your disaster manual in a front window to indicate that all in your household are ok. If you would be willing to be a "victim" for the drill, let me know (288-5570; wocdoc@earthlink.net).

All block monitors, at 10 a.m. on April 7, will check all houses on your block, using the survey sheets (if you need some, extras will be on my porch). Then report immediately to the incident command center in your area: 470 S. 14th for those south of San Carlos; 222 S. 14th for those north of San Carlos. We should be finished by 11 a.m.

If you are a block monitor and do not have helpers, now is the time to recruit them--especially if you will not be available on April 7.

If you are new to the neighborhood and do not have a prep manual, let me know. If you would like to join our emergency response team, also let me know.

History Naglee Park

Last year, CCA approved the Naglee Park History Project to document our homes' basic history by collecting data on building permits, parcel numbers, owners, occupants, architects, etc. and to develop a website with this information. Several neighbors volunteered to gather information and a database was begun. The project lost momentum when the coordinator moved from Naglee Park. Recently, several neighbors have asked about the status of the project and if this research could lead to Historic District status. Kris Dessau and I approached CCA Steering Committee at its 2/6/07 meeting requesting its support to create opportunities to discuss this possibility and explore what it would mean for the neighborhood.

Greater Naglee Park (including the area not in the Conservation District) consists of over 900 properties. Because it is so extensive, the team recommends that research and meetings should focus on the 00 hundred blocks and work south over time. Additional information about this proposal will be presented at the April CCA meeting. You can contact us any time, however, with questions, comments or offers to help.

Concerns should be directed to the Department of Transportation (DOT). If you see a dumping in a public area, whether it is caused by passing-by littering or homeless encampments or another source, call DOT at (408) 535-3850 to make a report. They will dispatch someone as soon as possible to take care of it. If they are all booked, ask the administrative assistant at DOT to patch you through to the emergency dispatch.
