San Jose Medical Center Shuts Down

On Thursday, December 9th, the San Jose Medical Center closed and locked its doors. Today, the hospital sits empty surrounded by cyclone fencing, police tape, and barbed wire. Its windows on 14th Street are boarded up.

The medical center opened 81 years ago as San Jose Hospital. Since then, the hospital has employed, healed, and given birth to many Naglee Park residents.

HCA's closure of the medical center has left the city and county scrambling for hospital beds and trauma services. Prior to the closure announcement in September, HCA reported that our

downtown hospital would not be closed until 2007. Now, the county and remaining trauma centers are trying to fill the void.

Both Valley Medical Center and Stanford Hospital are expanding their emergency and trauma care services. HCA is trying to expedite the creation of a replacement trauma center at San Jose Regional Medical Center.

But, none of these measures will take care of the immediate drop in service, or help downtown residents who need emergency care today.

The major concern to downtown residents is that now emergency hospital care may be limited during natural disasters. A large earthquake could destroy the bridges into downtown. As a result, downtown San Jose could be isolated from emergency rooms and trauma centers. This concern only grows as the population of downtown increases.

Assembly News

As my tenure in the State Assembly draws to a close, I would like to thank you for your assistance in the work and legislation that I have

accomplished. These past four years have been extremely busy; beginning with the energy crisis, the budget deficit, and a recall of the Governor, to name a few. Locally, issues such as the closure of San Jose Medical Center and the presidency at San Jose State University have received much of my attention.

This work would not have happened without your support and advice. Government works best when the people actively participate in the democratic process. This understanding is crucial because a healthy democracy requires that communities understand how a free system works.

I am proud of various bills I authored, especially the creation of a state fund giving incentives for counties to create a Children's Health Insurance Program, replicating the successful Santa Clara County Model "Healthy Kids." As Chair of the Assembly Select Committee on Housing, I worked with Silicon Valley leaders and community groups to pass legislation establishing a state-funded matching grant program for low-income housing and development, through which funds go to groups such as the Housing Trust of Santa Clara County which assists first-time homebuyers in making their dreams a reality.

Other successful legislative education issues included improving low-performing schools which increased minority student access and opportunities in higher education institutions, charter school reform, expanding student financial aid opportunities and improving teacher and staff development opportunities.

We also successfully fought to ensure that the state budget would not cripple the ability of local redevelopment agencies to provide important programs and neighborhood improvements.

Together we have taken steps to ease the congestion that clogs our freeways. We passed Proposition 42,

ensuring that highway repairs and construction would be properly funded. We have made unprecedented investments in our local mass transit, opening a light rail extension to Alum Rock and laying the groundwork for the BART extension to Santa Clara County.

I sincerely believe that through the many committees I worked on - Budget, Education, Insurance, Utilities and Commerce, Chair of the Budget Subcommittee on Transportation and Information Technology, I was able to help the people of the 23rd Assembly District and throughout the state.

Again, it has been an honor to serve you. I hope to continue working with you and to serve our community in the future.

The Naglee Homestead - A Reminiscence (part 2)

The following "Reminiscence" was published in The Raven, a popular magazine that was first published in Oakland. The article, which appeared in 1905, was written by someone in T.S. Montgomery's office - its purpose was to sell lots in the recently established Naglee Park.

For the builders of these homes are called from nearly every walk of life; there dwell men, mechanics, capitalists, and business people of numerous callings. It has not been the aim to restrict the advantage to the favored few, but rather to offer the opportunity of owning a home to appreciative men of all classes. Building is being fostered by hitherto unknown terms of liberality, and the results achieved attest the wisdom of this generous offer.

And even so, the good work is in its infancy, for the new awakening of progress in our Garden City has generously favored the Naglee Park Tract. Soon we are to see a new and enterprising street railway company construct its lines along San Fernando and San Carlos Streets. In a short while we shall witness the Santa Clara Street Railway in new hands, with a highly superior grade of cars, and greatly improved service.

With the completion of these great improvements, there will be no spot in Naglee Park from which a person may not step to find a car ready to convey him wherever he may wish to go.

The wonderful growth of this section of late, and the increasing demand for lots, has induced the Naglee Park Improvement Company to open a new tier of blocks, and so shall soon see the beauties of Naglee Park extended as far south as San Carlos Street. The contractor's street-plow and grader will soon be seen at work, preparing for the introduction of all those modern conveniences which characterize what we may now call the old Naglee Park Track. The improvement is to be made complete, new features being introduced to improve upon the old wherever possible.

Two years and a half have wrought almost magical changes upon the old Naglee Homestead, but, unless the signs entirely fail, we shall see far greater improvements within the next few years.

Naglee Park Tract is established as an ideal home section. Those who have built there are loudest in their praises, and this fact is both gratifying to the fathers of Naglee Park, and promises well for the future.
