## Bark in the Park 2006 is a Great Success

Bark in the Park 2006 marked the eleventh time that the Campus Community Association and the Naglee Park neighborhood has organized and hosted the Valley's premier event for Dog Lovers and their Best Friends. What began as an idea for a day at the park for our neighbors and their dogs has evolved into the most respected dog oriented festival in Northern California. Bark brings many benefits to our neighborhood and our downtown community.

Bark is the largest fundraiser for CCA Beautification. Over \$29,000 from the previous ten Barks has been invested in our Neighborhood Beautification efforts. This money from Bark in the Park, leveraged with thousands of volunteer hours, directed donations and grants, has resulted in hundreds of trees being planted, existing trees being maintained so they are healthy, medians planted and maintained and gateways beautified. Beautification is always

looking for new volunteers. Join Beautification and help invest our Bark in the Park revenues into our neighborhood.

Bark has also invested over \$10,000 in our greater downtown community. Some of our recent donations have been to the Horace Mann Foundation to enrich the educational experiences of downtown children, a donation to the San Jose High Academy Booster Club directed to the SJHA Band, a donation to Selma Olinder Elementary School for their enrichment programs and new playground, and a donation to Safe from the Start San Jose to promote literacy for children in San Jose. Bark has provided neighborhood association support by contributing to the United Neighborhoods of Santa Clara County, and contributed to our neighboring neighborhood associations to help them fund their community building events and projects. # From the Editors Desk

The elections are over, but political discussions continue to reign on the CCA email list. Not content to bicker over local politics, list members are now bickering about the worst politicians of the last 50 years. Who knows what they will bicker over next?

It is hard to imagine that these conversations fit the CCA email lists mission: Serve the community by providing an unmoderated, respectful venue for neighborhood communications. The list should improve communications, foster involvement, and help maintain a quality neighborhood but they continue. It should be no surprise that only a small percentage of email list members are also members of the CCA.

Every couple of years, someone gets fed up with the constant flow of political diatribes and suggests that a new list be created where political conversations can occur and allow the main CCA email list to return to its mission. Occasionally, these suggestions make it as far as the CCA Steering Committee.

The suggestions, however, are almost immediately shot down by many of the list members with statements like; I like the list the way it is; If you don't like the thread, just delete it; and I view the list as my personal soapbox etc.

The problem of course is that over time, the list membership has evolved into a group that enjoys arguing about politics and would probably be bored with more mundane neighborhood conversations. Those who would rather have neighborhood centric conversations usually leave the list after awhile.

So asking the list, whether we should move political discussions off to a new list will always generate the same response. The Steering Committee will never change the list as long as most people they ask oppose the change.

If the CCA Board really wants to gauge what its members think about the list, whether political discussions belong there, and how well the list serves them, they should ask the CCA members and not just the people on the email list.



# Pres' Says

I'm writing the CCA President's Column post-election. This past week San Jose has elected both a new Mayor and District Three Councilperson; this represents significant political change, with both challenges and opportunities.

Many Naglee Park neighbors were involved in election-related activities. Both those who were organizing for specific candidates and those who were advocating for the democratic process itself, like our neighbors who are active in the League of Women Voters who had signs in their front yards reminding us all to vote on Election Day. Did you know that the League has been active here in San Jose doing citizen education since 1945? That's an amazing record of service to the community.

It makes perfect sense that here in Naglee Park we are involved in the vibrant political dialogue that shapes our downtown. When you settle in a place and invest your hopes and dreams (as well as your financial future!), you want to engage and support its' success. Many of our neighbors spent much of the last year passionately advocating for specific candidates. Now that the election is over, we will all refocus our energies on the needs of the neighborhood, and work with our newly elected Councilperson and Mayor.

Many things are wonderful in Naglee Park, and we have a great working relationship with the City. However, here are some priorities that I see as vital to communicate to our new elected officials:

**Support the neighborhood in preserving what is good.** Here in Naglee Park that means supporting the efforts of neighbors who try to do the right thing for the community. We have a group of neighbors on one block who have been struggling to protect several historic homes, and the quality of their street. At times this has been frustrating, as the process is slow, and even being within the conservation area has not provided the level of protection as we would have hoped.

Naglee Park needs to trust that the City will partner with us to effectively enforce the law and code, so that we can preserve the architectural character of this community. This situation also requires us all to ask ourselves if we as a community are willing to take the steps needed to strengthen the legal protections available for our historic structures. The experience that we have seen this past year certainly should be a "wake-up call" that the time is now to take the necessary steps to protect the architectural character of Naglee Park.

**Let the neighborhoods define what we need in our downtown.** In the ten years I have lived in Naglee Park, one supermarket has opened, and one has closed. Hopefully, more retail, including supermarkets and other needed neighborhood friendly shops and services will open in downtown. While the new Coleman Market Center provides a number of shopping and dining options, it is not the same as having downtown neighborhood stores and services.

In the past, the City has often relied on outside consultants to define what is needed in downtown. Instead, the City should work directly with those of us who live and work downtown. In Naglee Park, among our neighbors are many downtown business owners. We know as a community what we residents would like to have available, and the business owners know what it takes to be successful downtown. Let us all work together with other neighborhoods and business leaders to build momentum so that we can accomplish these goals.

But a big part of the solution is adequate funding for police and other services, and that comes down to setting appropriate financial priorities.

And lastly, but perhaps most importantly, **Ask for our input, listen, and follow through.** Naglee Park is inhabited by opinionated people who truly love this place and care about their neighbors. My experience is that people aren't shy about sharing their views, and this dialogue is the greatest strength of this neighborhood. The voices of our community can also be valuable to our newly elected leaders. Naglee Park residents are available, and will give their time generously if we believe that you share our commitment to this special neighborhood.

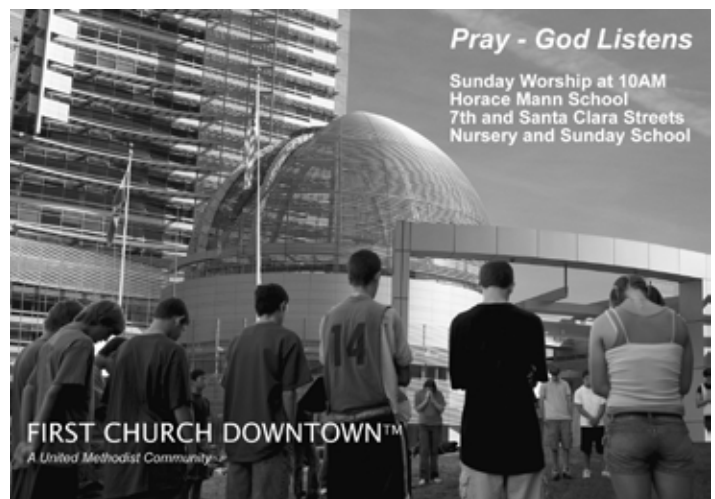

## Downtown Ice Skating Rink returns to Circle of Palms

Now in its third year at the beautiful Circle of Palms, Downtown Ice is gearing up again to bring the best outdoor experience possible to ice skaters along the West Coast. Nestled off Market Street between the San Jose Museum of Art and Fairmont San Jose, the rink is scheduled to open at 5 p.m. Friday, Nov. 17 and will operate daily through Jan. 15, 2007.

Downtown Ice celebrates its 11<sup>th</sup> season with two new programs – TGIceF and American Ice Theatre's Dance on Ice Workshop.

TGIceF allows skaters to celebrate the end of the work week in style. Stop by the rink for a special lunch and skate combination (\$20) from 11:30 a.m.-1:30 p.m. on Friday, Dec. 1, Dec. 8, Dec. 15, Jan. 5 and Jan. 12.

Want to learn to skate like the stars under the stars? Learn to dance on ice with American Ice Theatre, a San Jose-based professional ice dance company. AIT Artistic Director Jodi Porter will lead workshops that teach beginner and intermediate skaters contemporary ensemble pieces. The culmination of the 6:30-7:30 p.m. lessons on Nov. 29, Dec. 6, Dec. 13, Dec. 20, Jan.



3 and Jan. 10, is a performance on Jan. 15 - closing day of Downtown Ice. Registration is required at [www.americanicetheatre.org](http://www.americanicetheatre.org)

Of course, skaters of all abilities can spin and twirl around a perfectly circular inner rink, or use one of four open and safe portals through the trees and take longer laps on an outer ring. The rink is at its best after dark, when lights twinkle off the 32 palms and stars shine from overhead. In general, the rink is open 5-10 p.m. weeknights and noon to midnight on weekends and during the busy holiday period Dec. 17-31.

Cost of unlimited ice time and skate rentals is \$12 for 12-under and \$14 for 13-over.
